**AND WHEREAS** with a view to and for the purpose of constituting the Trust permanently for the purpose of carrying on the objectives of the Trust as mentioned hereafter under the "Aims and Objects" clause of this Deed of Trust, it is considered desirable that for the purpose of creation of this Trust the declaration of the Trust should be made in the manner set out hereunder.

**NOW THIS INDENTURE WITNESSETH AS FOLLOWS:-**

Name of the Trust shall be:- **S.B. EDUCATIONAL & SOCIAL WELFARE TRUST**

The Registered Head office of the Trust shall be located at Vill-Bhadiswar, P.O-Murarai, P.S-Murarai, Dist-Birbhum, Pin-731219, and West Bengal, India. The office of the Trust may be opened to any other place in West Bengal or to any other of India or open local office or offices at Places deemed necessary.

1. **INTERPRETATION:-**

- a) Trust means the Trust created by this Deed Viz. ....
- b) The Board shall mean the Board of the members which may be filled up by co-option of the existing Trustees created by this Deed with renowned and suitable persons.
- c) **TRUST PROPERTY:-** shall include every kind of property movable and immovable to be owned by the Trust and mentioned in accounts, books and other documents in the possession, custody and control or that ought to be in possession, custody and control or possession of the Trust.


2. **AIMS AND OBJECTS OF TRUST:-**



To promote, establish, start, maintain, organize, run, manage, supervise, superintendent, co-ordinance, affiliate, control, guide and grant aid to the, Vocational center, libraries, Mission, School, Foreign leagues course, auditorium, and other educational institutions for the promotion of the arts, literatures, science and commerce:

To establish, maintain, control, manage and or render financial assistance medical college, including all treatment facilities to hospitals, health centers, nursing home, dispensaries, maternity homes, clinics, sanatorium and other establishments for providing medical facilities and to promote medical research in these centers in all faculties and systems of medical practices and provide medical help including supply of medicines providing Ambulance services, arrangement of medical van and medical unit to the public irrespective of any caste, colour and need and to promote research for medicines for cancer and other incurable diseases:
- iii. To start, support, organize and give financial aid to the social, cultural and moral renaissance of the people and to develop physical, mental and educational capacity of the Trust and to promote schemes for such purposes:





- xl. To undertake housing and resettlement activities for economically or otherwise disadvantaged people in rural and urban areas by way of concept formulation surveying planning supervising, producing of low cost and innovative building materials, construction, financing, management, research and development and/or training:
- xli. To raise fund by way of loan, donations, fees etc. from any person/s, the state or central Government Organizations, companies corporate agencies, institutions or otherwise for the TRUST and/or to provide funds to such beneficiaries as many be identified by the TRUST:-
- xlii. 3. To perform that notwithstanding herein contained in the income as the corpus OF THE TRUST fund the same shall be applicable and applied to for PUBLIC CHARITABLE PURPOSE ONLY within such territories and subject to such conditions or limitation if any as may from time to time be laid down by the Income Tax Act, 1961 or any other acts governing taxation of income the wealth of PUBLIC CHARITABLE TRUST so as to render the TRUST hereby established as well as its income eligible for exemption from taxation under such Act or acts, now or prevailing or any modification replacement thereof.

4. To act in such a way that the TRUST hereby established shall always retain the status of one such TRUST to which provisions of section 80G/ 12A/ 35AC/FCRA 10(23C) IV/V/VIA of the Income Tax Act, 1961 or any modification replacement or thereof for the time being in force shall apply so that any donation or

contribution thereto is recognized as eligible for exemption or relief from tax in the hands of the donor.

5. **ADMINISTRATION:-** The properties and funds shall vest in the name of Trustees constituted by persons executing the Deed of the Trust. The number of members of Board of Trustees shall not exceed 15 and the vacancies can be filled by co-option by the existing Trustees.

6. **OFFICE BEARERS:-**

Office bears of the trust shall be initially as follows:-

The Board of Trustees is also Empowered to created any office bearer post and elect office bearers to fill up the post form the Trustees and/or from outside the Board of Trustees. The above office-bearers shall be elected by the co-option of the Trustee at a meeting convened for the purpose.

7. **VACANCIES:-**

A vacancy shall arise among the Trustees in the following cases-

- i. When a Trustee dies.
- ii. When he resigns his office as a Trustee.
- iii. If he becomes Bankrupt.
- iv. If he becomes in sane or otherwise become incapable to act or.
- v. When he is absent from three consecutive meeting of the Board, unless the Board records condoning such absence in the minutes of the meetings of the Board of Trustees for substantial cause.
- vi. When it becomes insolvent.
- vii. When convicted of any criminal offence involving moral Turpitude.
- viii. When he acts or does anything detrimental to the interest of the Trust.
- ix. On medical evidence when he is declared physically or mentally unfit by a resolution of the Board at a meeting convened for the purpose.

7 (A) **FUNCTIONS OF THE OFFICE BEARERS:-**

**PRESIDENT:-**

- i. President **WILL BE ELECTED BY THE MAJORITY OF THE MEMBERS** trustees present in the meeting convened for the purpose.
- ii. The president is empowered to take decisions on urgent matters, but such be approved by the Board within a period of 30 days.
- iii. The President will preside over the meeting of the Trust and conduct the proceedings.
- iv. The president in his own decision or by the request of the third of existing members can call for the meeting of the Trustees.
- v. The President is empowered to delegate such powers to any other members of the Trust as he may deem fit.
- vi. The President is empowered to dissolve the committee or the Board in any abnormal situation.

**VICE-PRESIDENT:-**

In absence of the president Vice- president shall have all the power of the president.

**SECRETARY:-**

The Secretary who will act as managing trustee of the Board of Trust, elected under the control and supervision of the Board, shall conduct and manage all the affairs of the Trust, it's properties and institutions, sign papers and carry on the despondence on behalf of the Trust, and shall be responsible for the safe custody of records of the

Trust, and keeping of the proper accounts thereof. He shall also perform such other duties as may be entrusted to him from time to time by the Board provided that in the absence of the Secretary. The President, the Vice-President of the Assistant Secretary or any other Secretary especially authorized on the behalf may sign papers and carry on correspondence on behalf of the Trust and do all or any of the duties relating to the Secretary under this Clause. The Secretary shall attend to the correspondence and today affairs of the Trust. The Secretary shall carry out all the resolution of the Trust and for that purpose he shall have power to incur necessary expenditure form and cut of the funds of the Trust. He shall have the custody of the correspondence and other books relating to the affairs of the Trust.

**ASSISTANT SECRETARY:-**

The Assistant Secretary shall assist the Secretary in all affairs of the Trust. In absence of the Secretary and on Special authorization he will have the powers and to perform duties of the Secretary.

**TREASURER:**

The Treasurer shall conduct and receive all sorts of subscriptions, donations and deposit or money and grant receipts of money thereof. He will maintain and keep cash book and such other books of accounts as are necessary.

**8. FOUNDER MEMBERS:**

**Sanjida Yeasmin** D/O Abdur Rahaman, by Faith- Muslim , By occupation- Lawyer, Nationality- Indian, Residing at Vill-Durja , P.O- Murarai, P.S- Murarai, Dist- Birbhum, Pin-731238, West Bengal, India in the post of Vice President of this Trust Deed dated constituted on the 13<sup>th</sup> day of September, 2017 shall be the member for life.

**9. NO PERSON BEING:-**

- i) An undercharged insolvent; or
  - ii) Convicted of an offence involving moral turpitude. Or
  - iii) Of unsound mind or
  - iv) A minor;
  - v) Shall be eligible to be a Trustee.
10. The Board of Trustees may, by a unanimous vote of all the Trustees for the time being except the Trustee proposed to be removed, remove any Trustee, permanent or otherwise, from office after finding the Trustee proposed to be removed guilty of serious misconduct in relation to or covering the trust estate or trust estate or trust affairs and after arriving at definite conclusion that for the reasons to be recorded in within the continuance of the Trustee proposed to be removed as Trustee or these presents was desirable keeping to the object of the trust in view other related or connected matters provided however that on conclusion of such shall be arrived at without giving to the Trustee proposed to be removed a full and fair opportunity of explaining his conduct and/or the charges leveled against his for his removal and the decision of the Board of Trustees in this behalf shall final and binding and shall not be called nay question anywhere.
